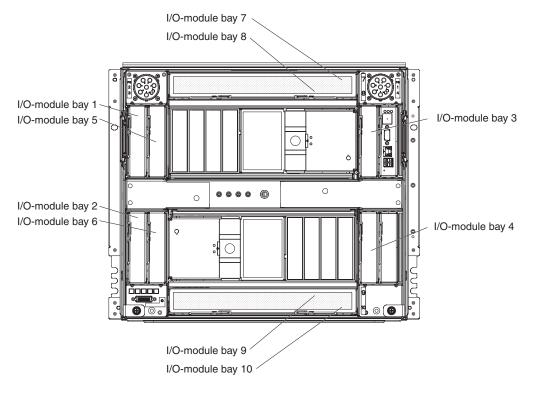
### **Chapter 1. Introduction**

This Installation and User's Guide contains instructions for and information about:

- Installing or replacing the 4X InfiniBand Pass-thru Module for IBM<sup>®</sup> BladeCenter<sup>®</sup>
- Enabling the 4X InfiniBand Pass-thru Module and its external ports
- · Using the status LEDs and external ports on the 4X InfiniBand Pass-thru Module
- · Performing basic troubleshooting of the 4X InfiniBand Pass-thru Module

To support each high-speed I/O module that you install in the BladeCenter unit, you must also install a compatible high-speed expansion card in each blade server that you want to communicate with the high-speed I/O module. For installation details, see Chapter 2, "Installing, replacing, and enabling an I/O module," on page 7. For additional information about expansion cards and other BladeCenter components, see the BladeCenter documentation that comes with these devices.

The following illustration shows an example of a BladeCenter H unit with the I/O-module bays identified. In this example, these bays are in the rear of the BladeCenter chassis. In a different type of BladeCenter unit, the bays might be in a different location. #### Notes:

- 1. The illustrations in this document might differ slightly from your hardware.
- Throughout this document, the 4X InfiniBand Pass-thru Module for IBM BladeCenter is generically referred to as the pass-thru module or the I/O module.

With respect to certain screen contents or titles, this product might be referred to as an I/O module, a switch module, or a switch, because the term I/O module, switch module, or switch appears on those screens.

- The screens that are described or referenced in this document might differ slightly from the screens that are displayed by your system. Screen content varies according to the type of BladeCenter unit and the firmware versions and options that are installed.
- 4. Unless otherwise stated, references to the BladeCenter unit apply to all supported BladeCenter unit types, such as the BladeCenter H unit.
- Unless otherwise stated, references to the management module apply to all supported types of BladeCenter management modules, such as the BladeCenter Advanced Management Module.
- 6. Using the CFFv expansion card in combination with a CFFh expansion card in a high-speed blade server provides simultaneous connections to both the I/O-module bays 3 and 4 in all BladeCenter unit types and the BladeCenter high-speed I/O-module bays (7 through 10).
- 7. The I/O modules in I/O-module bays 7/8 and 9/10 must support high-speed operation.
- 8. Use a compatible cable, such as one of the following types of cable, with the I/O module:
  - IBM InfiniBand 3m DDR 4X Copper Cable
  - IBM InfiniBand 8m DDR 4X Copper Cable

### **High-speed technology overview**

The 4X InfiniBand Pass-thru Module for IBM BladeCenter provides high bandwidth, low latency, non-blocking, 10 Gbps (Gigabits per second) and 20 Gbps single-data rate (SDR) and double-data rate (DDR) InfiniBand connectivity to the blade servers in the BladeCenter unit. You can increase the benefits of having BladeCenter architecture in your system configuration by using the pass-thru module in combination with the external InfiniBand, Ethernet, and Fibre Channel switching capabilities of various I/O modules.

The pass-thru module uses repeaters to improve signal integrity. The pass-thru module is managed by the IBM Advanced Management Module for IBM BladeCenter through a connection to the chassis midplane in the BladeCenter unit. Thus, the pass-thru module does not require and does not contain an InfiniBand Subnet Management (SM) function.

The pass-thru module is a double-height, high-speed device that occupies two I/O-module bays in the rear of the BladeCenter unit. You can install a maximum of two I/O modules in the BladeCenter unit. You can install one pass-thru module in I/O-module bays 7/8, and one pass-thru module in I/O-module bays 9/10. Installing two pass-thru modules provides dual-path connections to the expansion card in a blade server.

For an illustration that shows the pass-thru module installed in the IBM BladeCenter H unit, see Chapter 2, "Installing, replacing, and enabling an I/O module," on page 7.

The maximum number of blade servers that you can connect to the BladeCenter unit varies according to the type of BladeCenter unit that you are using. The BladeCenter H unit can contain a maximum of 14 blade servers. Each blade server can host an InfiniBand host channel adapter (HCA). Each HCA has two InfiniBand ports that connect to the pass-thru modules that are installed on the rear of the BladeCenter unit. Port 0 of each HCA connects to the pass-thru module that is installed in bays 7/8 at the top rear of the BladeCenter unit. Port 1 of each HCA connects to the pass-thru module that is installed in bays 9/10 at the bottom rear of the BladeCenter unit. The pass-thru modules connect the blade servers to external high-speed switch modules (HSSMs) and switches.

To enable communication between blade servers and the pass-thru module, you must install a compatible high-speed expansion card in each blade server that you want to communicate with the pass-thru module. The pass-thru module is compatible with the following types of expansion cards:

4X InfiniBand DDR Expansion Card (CFFh) for IBM BladeCenter

- · Cisco 4X InfiniBand DDR Expansion Card (CFFh) for IBM BladeCenter
- Voltaire 4X InfiniBand DDR Expansion Card (CFFh) for IBM BladeCenter

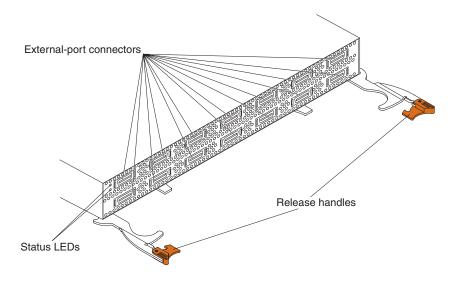

### Chapter 2. Installing, replacing, and enabling an I/O module

This chapter provides information about and instructions for installing, replacing, and enabling an I/O module in the BladeCenter unit.

To support each high-speed I/O module that you install in the BladeCenter unit, you must also install a compatible high-speed expansion card in each blade server that you want to communicate with the high-speed I/O module. In this configuration scenario, the expansion card is also known as a host channel adapter (HCA). You can install a maximum of two I/O modules in the BladeCenter unit.

- For the locations of the BladeCenter unit I/O-module bays, see Chapter 1, "Introduction," on page 1.
- The blade servers or BladeCenter units that are described or shown in this
  document might be different from your blade server or BladeCenter unit. For
  additional information, see the documentation that comes with your blade server
  or BladeCenter unit.
- Configuration requirements for expansion cards, blade servers, and the BladeCenter unit might vary. You can obtain up-to-date information about these devices at http://www.ibm.com/systems/bladecenter/.
- Changes are made periodically to the IBM Web site. Procedures for locating firmware and documentation might vary slightly from what is described in this document.

#### Notes:

1. Installing two I/O modules provides dual-path connections to the expansion card in a blade server. A dual-path connection enables a redundant path and a separate connection from a blade server to the external InfiniBand network.

- 2. If I/O modules are installed in both I/O-module bays 7/8 and 9/10, both I/O modules must be of the same type. Installing a second I/O module in the BladeCenter unit provides a backup I/O module in case one I/O module fails. This configuration is also known as redundant, dual-switch topology.
- 3. Installing only one I/O module in the BladeCenter unit creates a single-path connection to the expansion card in a blade server. This non-redundant, single-switch topology does *not* provide a backup I/O module in case of failure.

See the following BladeCenter documentation for additional information:

- The *Installation and User's Guide* for your blade server provides server specific expansion card installation requirements.
- The Installation Guide for your BladeCenter unit shows the I/O-module bay locations. This document also contains installation and configuration instructions for other types of I/O modules that you might need to install in the BladeCenter unit; for example, a power module.

### Installation guidelines

Before you install the I/O module or the blade server in the BladeCenter unit, read the following information:

- Read the safety information that begins on page v, "Handling static-sensitive devices" on page 10, and the safety statements in the BladeCenter unit documentation. This information will help you work safely.
- Observe good housekeeping in the area where you are working. Place removed covers and other parts in a safe place.
- Blue on a component indicates touch points, where you can grip the component to remove it from or install it in the blade server or BladeCenter unit, open or close a latch, and so on.
- Orange on a component or an orange label on or near a component on the I/O module, blade server, or BladeCenter unit indicates that the component can be hot-swapped, which means that if the BladeCenter unit and operating system support hot-swap capability, you can remove or install the component while the BladeCenter unit is running. (Orange can also indicate touch points on hot-swap components.) See the instructions for removing or installing a specific hot-swap component for any additional procedures that you might have to perform before you remove or install the component.
- You do not have to turn off the BladeCenter unit to install or replace any of the hot-swap modules on the front or rear of the BladeCenter unit.
- When you install an I/O module in the BladeCenter unit, you must also install a compatible I/O expansion card in the blade server to support the I/O module.
- The pass-thru module is a double-height device that requires two high-speed I/O-module bays (7/8 or 9/10) in the BladeCenter unit. Therefore, the following conditions apply:
  - Before you install an I/O module in the BladeCenter unit, you must remove the filler modules from the two bays that you have selected for the I/O module
  - If you remove an I/O module from the BladeCenter unit and you do not replace the I/O module with another I/O module, you must replace the I/O module with *two* filler modules. You must install the filler modules in I/O-module bays 7/8 or 9/10 in the BladeCenter unit.

- When you are attaching a 4X InfiniBand cable to the I/O module:
  - Do not fold, bend, or twist the cable.
  - Do not over-bend the cable behind the connector.
  - Do not twist the cable connector.

- When you are finished working on the blade server or BladeCenter unit, reinstall all safety shields, guards, labels, and ground wires.
- Make sure that you are using the latest versions of device drivers, firmware, and BIOS for your blade server, management module, and I/O modules that are used by the I/O expansion card. See http://www.ibm.com/systems/support/ for the latest information about upgrading the device drivers and firmware for BladeCenter components. See the latest instructions in the documentation that comes with the updates.

### System reliability guidelines

To help ensure proper cooling, performance, and system reliability, make sure that the following requirements are met:

- Each of the module bays on the rear of the BladeCenter unit contains either a module or a filler module.
- A removed hot-swap module is replaced with an identical module or filler module within 1 minute of removal.
- A removed hot-swap blade server is replaced with another blade server or filler blade within 1 minute of removal.
- The ventilation areas on the sides of the blade server are not blocked.
- You have followed the reliability guidelines in the documentation that comes with the BladeCenter unit.

Cable requirements for the I/O module are described in the IBM *Configuration and Options Guide* at http://www.ibm.com/servers/eserver/xseries/cog/. See the documentation that comes with the blade server for cable-routing information. If you must install cables for other BladeCenter components, see the cable-routing information in the documentation that comes with the BladeCenter components and the cables.

### Handling static-sensitive devices

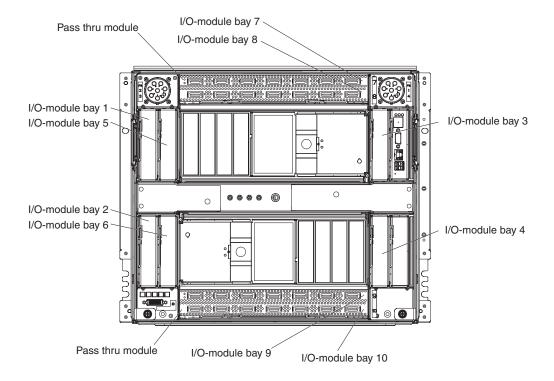
**Attention:** Static electricity can damage the BladeCenter unit and other electronic devices. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- · Limit your movement. Movement can cause static electricity to build up around
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and damage it.
- · While the device is still in its static-protective package, touch it to an unpainted metal surface of the BladeCenter unit chassis or an *unpainted* metal surface on any other grounded rack component in the rack that you are installing the device in for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into the BladeCenter unit without setting down the device. If it is necessary to set down the device, put it back into its static-protective package. Do not place the device on the BladeCenter unit or on a metal surface.
- · Take additional care when you handle devices during cold weather. Heating reduces indoor humidity and increases static electricity.
- Some types of BladeCenter units come with electrostatic discharge (ESD) connectors. If the BladeCenter unit is equipped with an ESD connector, see the documentation that comes with the BladeCenter unit for using the ESD connector.

### Installing the I/O module

See the BladeCenter unit documentation for detailed instructions for installing the I/O module.



To install an I/O module, complete the following steps:

- Make sure that you are using the latest versions of device drivers, firmware, and BIOS code for your blade server and management module. Go to the IBM Support Web site, http://www.ibm.com/systems/support/ for the latest information about upgrading the device drivers, firmware, and BIOS code for BladeCenter components. The latest instructions are in the documentation that comes with the updates.
- 2. Read the safety information that begins on page v and "Installation guidelines" on page 8.
- Make sure that the BladeCenter unit is turned on, the green dc power LED on each power module is lit, and the green OK LED on the management module is lit.
- 4. Select only I/O-module bays 7/8 or 9/10 in which to install the I/O module.

**Note:** For details about I/O-module bay requirements and bay locations, see the documentation for the BladeCenter unit, blade servers, and the applicable device.

- 5. Remove the filler modules from the two selected bays (7/8 or 9/10). Store the filler modules for future use.
- 6. If you have not already done so, touch the static-protective package that contains the I/O module to an *unpainted* metal surface of the BladeCenter chassis or an *unpainted* metal surface on any other grounded rack component in the rack in which you are installing the I/O module for at least 2 seconds.
- 7. Remove the I/O module from its static-protective package.

- 8. Make sure that the release handles on the I/O module are in the open position (perpendicular to the I/O module).
  - Depending on the type of BladeCenter unit that you are using, the installation procedure requires either a vertical or horizontal orientation for the I/O module. For information about installing an I/O module in your type of BladeCenter unit, see the documentation that comes with the BladeCenter unit.
- 9. Slide the I/O module into the applicable I/O-module bays until it stops.
- 10. Secure the I/O module to the chassis by pushing the I/O-module release handles inward to the closed position.

#### Attention:

When you are attaching a 4X InfiniBand cable to the I/O module:

- · Do not fold, bend, or twist the cable.
- · Do not over-bend the cable behind the connector.
- · Do not twist the cable connector.
- 11. Connect all of the necessary 4X InfiniBand cables to the I/O module.

Note: For cabling information, see the Configuration and Options Guide at http://www.ibm.com/servers/eserver/xseries/cog/.

12. Push the release handles on the front of the I/O module to the closed position. After you insert and lock the I/O module, it is turned on, and a power-on self-test (POST) occurs to verify that the I/O module is operating correctly.

Note: The I/O module takes approximately 5 seconds to complete the POST. When the I/O module is turned on, an LED test occurs. All LEDs are lit and remain lit for approximately 2 seconds; then, all the LEDs except the OK LED turn off. The OK LED flashes to indicate a normal POST

- 13. Make sure that the LEDs on the I/O module indicate that it is operating correctly. (For LED locations, see "Status LEDs" on page 18.)
  - When the POST starts, make sure that the green OK (power) LED on the I/O module is flashing. The POST tests the condition of firmware, memory, data paths, and switch logic and uses the fault LED (amber) on the I/O module to indicate pass or fail conditions.
  - · Make sure that the green OK LED on the I/O module stops flashing to indicate that the switch logic has completed POST.

**Note:** If the fault LED on the I/O module continues to be lit, the POST has failed. Make sure that the BladeCenter unit is powered on and the BladeCenter unit LEDs are lit. If POST has failed, see the following sections for diagnostic information:

- "Status LEDs" on page 18
- Chapter 5, "Solving problems," on page 23

An amber LED on the BladeCenter unit is lit when a system error or event has occurred. To identify the error or event, check the other LEDs on the I/O module, and check the BladeCenter management-module event log or the switch system log.

- 14. If you have a second I/O module to install, repeat step 4 on page 11 through step 13; otherwise, go to step 15.
- 15. If you are using the external I/O-module ports, you can connect an optional device, such as a high-speed switch module, to these ports. For device installation instructions, see the documentation that comes with the device.

16. Enable the new I/O module and its external ports through the management module, as described in "Enabling the I/O module and its external ports" on page 14.

### Removing or replacing an I/O module

To remove or replace an I/O module, complete the following steps:

- 1. Read the safety information that begins on page v and "Installation guidelines" on page 8.
- 2. Disconnect the cables from the external ports on the I/O module. Removing these cables disrupts the network connection from the external port to any connected external devices, such as high-speed switch modules. For removal instructions, see the documentation that comes with the cable options.
- 3. If you are replacing the I/O module with another I/O module and if you are using the existing external devices with the replacement I/O module, do not remove these external devices from the cables that you disconnected in step 2. If you are not using the existing external devices with the replacement I/O module or if you are not replacing the I/O module with another I/O module, remove any devices from the cables that you disconnected in step 2. For device removal instructions, see the documentation that comes with the devices. Store the devices for future use.
- 4. Pull the release handles toward the bottom of the I/O module. The I/O module moves out of bays 7/8 or 9/10 approximately 0.6 cm (0.25 inch).
- 5. Slide the I/O module out of bays 7/8 or 9/10 and set it aside.
- 6. Place either another I/O module or two filler modules in bays 7/8 or 9/10.

  Important: Complete this step within 1 minute. (For more information, see step 4 on page 11 through step 13 on page 12; then, return here and continue with the next step.)
- 7. If you placed another I/O module into bays 7/8 or 9/10 and if you are using the external I/O-module ports with the existing devices that were attached to the removed I/O module, reconnect any cables that you disconnected in step 2. If you disconnected the external devices that were attached to the removed I/O module in step 3 and you are attaching a new external device to the replacement I/O module, connect one end of a compatible cable to the new device. Connect the other end of the cable to one of the external I/O-module ports. For device installation instructions, see the documentation that comes with the devices. Then, reconnect any cables that you disconnected in step 2. For more information, see the documentation that comes with the cable options.

- 8. Enable the new I/O module and its external ports through the management module, as described in "Enabling the I/O module and its external ports." For additional information about the management module and enabling ports through the management module, see the following documents on the IBM Support Web site, http://www.ibm.com/systems/support/:

### Enabling the I/O module and its external ports

After you install an I/O module, you must enable the I/O module and its 14 external ports to complete the process that makes them fully operational. To do this, use the BladeCenter Advanced Management Module.

- The contents of all management-module Web-interface pages vary according to the type of BladeCenter unit that you are using and the firmware versions and options that are installed.
- The 14 external I/O-module ports correspond to the connectors for the blade servers that you can attach to the BladeCenter unit. For the location of the external ports, see the illustration in "External-port connectors" on page 19.

To enable an I/O module and its external ports, complete the following steps:

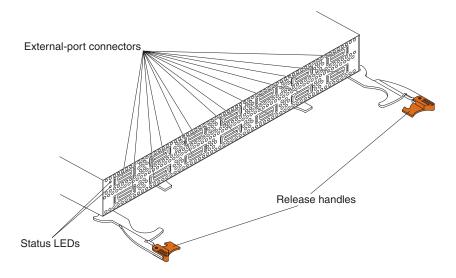
- 1. Start a management-module session by using a Web browser to connect to the BladeCenter Advanced Management Module. To do this, use the Advanced Management Module Internet protocol (IP) address. The BladeCenter management-module Web-interface page opens.
- 2. In the Advanced Management Module window, under I/O Module Tasks (left pane), click Admin/Power/Restart. The I/O Module Power/Restart window opens.
- 3. In the main window, select the I/O module that you want to turn on by checking the box in the first column.
- 4. Click the Power On Module(s) link at the bottom of the table. The I/O module is powered on, and a power-on self-test (POST) is performed. This might take several moments to complete. At the end of the process, the following actions occur:
  - a. In the table, the power (**PWR**) status column will change to ON.
  - b. In the table, the Power On Self Test (POST) Status column displays: "POST results available: FF: Module completed POST successfully." For additional POST values, see Chapter 5, "Solving problems," on page 23.

- c. The green LED (OK) located on the I/O module will be constantly lit. For additional information about LEDs, see Chapter 3, "Status LEDs and external ports," on page 17.
- 5. In the Advanced Management Module main window, scroll down to the **I/O Module Advanced Setup** choice.
- From the drop-down menus, select the applicable I/O module.
   Important: Do not skip step 7. If you skip step 7, the ports will not operate.
- 7. Select the **Enable** choice for the external ports.
- 8. Click **Save**. The I/O module and its external ports are now fully operational.

### Chapter 3. Status LEDs and external ports

This chapter describes the status LEDs on the pass-thru module and identifies the external ports on the pass-thru module.

Note: The illustrations in this document might differ slightly from your hardware.



The pass-thru module contains:

- LEDs that display the status of the I/O module and its network connections. (See "Status LEDs" on page 18.)
- 14 external high-speed ports to connect 4X InfiniBand high-speed host channel adapters (HCAs) in the blade servers. The corresponding port number is below each port on the I/O module. In the I/O-module configuration menus, these ports are identified as ports 1 through 14, and the internal connectors are numbered 1 through 14.

For additional information about the external ports, see "External-port connectors" on page 19.

### LED states and colors

After you install the I/O module in the BladeCenter unit, the I/O-module LEDs become active. There are four possible LED states: off, lit, flickering, and flashing. The lit (steady) LEDs and flashing LEDs can be green or amber. A flickering LED can only be green.

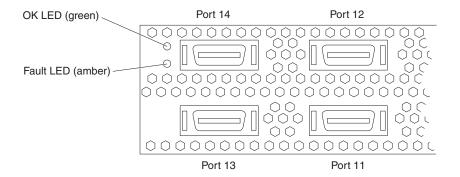
The LEDs might display any of these states and colors during startup, POST, or other diagnostic tests. This is typical and does not indicate a problem, unless the LEDs indicate a problem after all the startup (boot) processes and diagnostic tests have been completed.

Any errors that are detected during POST are written to the system log. This log is accessible through the management module. For information about the management module, see the documentation that comes with the management module. For information about POST error codes, see Chapter 5, "Solving problems," on page 23.

**Note:** You can also use the management module to make sure that the I/O module is operating correctly. For more information, see the documentation for the BladeCenter unit.

### Status LEDs

There are two LEDs on the top left side of the I/O module: OK (green) and fault (amber). These LEDs represent the I/O-module status. The following illustration shows the locations of these LEDs on the I/O module.



#### Notes:

- An amber LED on the BladeCenter unit is lit when a system error or event has
  occurred. To identify the error or event, check the other LEDs on the I/O module,
  and check the BladeCenter management-module event log or the switch system
  log.
- An LED test occurs whenever the I/O module is turned on. All LEDs are lit and remain lit for approximately 2 to 3 seconds during POST, and then all the LEDs except the OK LED turn off. The OK LED flashes to indicate a normal POST condition; then, POST proceeds as described in Table 3 on page 26.

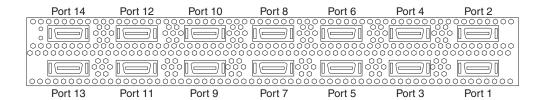
Table 2 contains a description of each status LED on the information panel. For the descriptions of the status LED activities and corresponding I/O-module conditions and status, and the applicable user actions, see Table 3 on page 26.

Table 2. I/O-module LED descriptions

LED name	LED description
OK	This green LED is at the top left of the I/O module, to the left of port 14, on the front panel. When this LED is lit, it indicates that the I/O module has passed the POST and is operational.
Fault	This amber LED is below the OK LED on the front panel. This LED indicates that the I/O module has a fault. If the I/O module fails the POST, this LED is lit.  Note: This LED is also known as the system-error LED or the I/O-module fault LED.

### **External-port connectors**

There are 14 external connectors for high-speed ports on front of the I/O module, as shown in the following illustration. The order of the external ports is from right to left.



The following port-mapping information applies to the pass-thru module. Use this information to help you determine which ports to select for connecting the pass-thru module to the blade bays in the BladeCenter unit. Also, you will use this information when you enable the I/O module and its 14 external ports through the management module.

- The following ports are on the top row of the I/O module: 2, 4, 6, 8, 10, and 12. These ports match the even-numbered blade bays in the BladeCenter unit.
- The following ports are on the bottom row of the I/O module: 1, 3, 5, 7, 9, 11, and 13. These ports match the odd-numbered blade bays in the BladeCenter unit.
- In the I/O-module configuration menus, these I/O-module ports are identified as ports 1 through 14, and the internal connectors are numbered 1 through 14.

**Note:** For instructions for enabling the I/O-module external ports through the management module, see "Enabling the I/O module and its external ports" on page 14.

### **Chapter 4. Parts listing**

Replaceable components are of three types:

- Tier 1 customer replaceable unit (CRU): Replacement of Tier 1 CRUs is your responsibility. If IBM installs a Tier 1 CRU at your request, you will be charged for the installation.
- Tier 2 customer replaceable unit (CRU): You may install a Tier 2 CRU yourself or request IBM to install it, at no additional charge, under the type of warranty service that is designated for your server.
- Field replaceable unit (FRU): FRUs must be installed only by trained service technicians.

    the filler modules from the two bays that you have selected for the I/O
    module.
  - If you remove an I/O module from the BladeCenter unit and you do not replace the I/O module with another I/O module, you must replace the I/O module with two filler modules. You must install the filler modules in I/O-module bays 7/8 or 9/10 in the BladeCenter unit.

### **Chapter 5. Solving problems**

This section provides basic troubleshooting information to help you solve some problems that might occur while you are setting up the I/O module.

If you are having a problem with the I/O module, use the following information to help you determine the cause of the problem and the action to take. Additional troubleshooting and debugging procedures are available in the *Problem Determination Service Guide* or *Hardware Maintenance Manual and Troubleshooting Guide* for the:

- BladeCenter unit
- · Blade server

Make sure that you are using the latest versions of device drivers, firmware code, and BIOS code for your blade server, the management module, and the I/O modules that are used by the expansion cards in the blade server. If these items are obsolete, the BladeCenter unit might not recognize the high-speed I/O module (that is, the pass-thru module) and might not turn it on. To download the most recent device drivers and firmware and BIOS boot code updates, go to http://www.ibm.com/systems/support/ for the latest information about upgrading the device drivers, firmware, and BIOS code for BladeCenter components. The instructions are in the documentation that comes with the updates.

#### Notes:

- Changes are made periodically to the IBM Web site. Procedures for locating firmware and documentation might vary slightly from what is described in this document.

### **Running POST**

To ensure that it is fully operational, the I/O module processes a series of tests during power-up or a restart (power-on self-test, or POST). These tests take approximately 5 seconds to complete. The management module reads the test results and displays them for you. During normal operation, these tests are completed without error, and the green OK LED is lit. However, if the I/O module fails POST, the amber I/O-module fault LED and the system-error LED on the BladeCenter unit are lit. An event is stored in the event log in the system status panel of the management module. The specific failure is displayed on the system status I/O module panel of the management module.

**Note:** For the locations and descriptions of the I/O module LEDs, see Chapter 3, "Status LEDs and external ports," on page 17.

#### POST noncritical and critical errors

There are two types of errors: noncritical and critical. A noncritical error applies to one port, and the I/O module is operational. You can continue to operate the I/O module; however, you must replace it or the faulty device that is connected to it as soon as possible. When critical errors occur, the I/O module does not operate. To view POST results, complete the following steps:

 Log on to the management module as described in the IBM BladeCenter Management Module Command-Line Interface Reference Guide. If necessary, obtain the IP address of the management module from your system administrator. The login window opens.

**Note:** If you need to see the latest version of the *IBM BladeCenter Management Module Command-Line Interface Reference Guide*, go to the IBM Support Web site, http://www.ibm.com/systems/support/.

- 2. Make sure that the I/O module and its external ports have been enabled, as described in "Enabling the I/O module and its external ports" on page 14. After you install an I/O module, you must enable the I/O module and its external ports to complete the process that makes them fully operational. To do this, use the BladeCenter Advanced Management Module. For additional information about the management module, see the documentation that comes with the management module.
- After POST is completed, the management module displays the results. Refresh
  the window to view the POST results. If a critical error occurs, replace the I/O
  module. If a noncritical error occurs, see the I/O-module error log for additional
  details.

The following table describes the basic critical and noncritical failures. This abbreviated list is representative; it is not an exhaustive list. An error code is associated with each failure. Error codes are displayed on the Management Module Switch Information window. Be sure to note the applicable error code and corresponding failure. You might have to provide this information when you call for service. For details, see Appendix A, "Getting help and technical assistance," on page 33.
